The Clinical Development Department is involved in the drug development process from preparation of Phase I through all phases to the market. The MPD is a key member of the project team and also a member of the Asset Team. The MPD reports to the Head of Clinical Development.

The MPD will be responsible for the medical and clinical development components of the clinical programmes from the clinical/scientific and strategic perspective. This task includes being knowledgeable of competitive product development in the field as well as seeking scientific updates (e.g. conferences) on advances in biology.
